**IN CONSIDERATION** of receiving permission from the Iditarod Trail Committee, Inc. ("ITC") to participate as an Idita-Rider passenger in the Iditarod Sled Dog Race, the receipt of permission being hereby acknowledged, the undersigned, for him/herself, his/her marital community and estate, heirs, executors, administrators, successors, trustees and assigns, hereby waives, releases and holds harmless the ITC, its officers, directors, employees, agents, volunteers, contributors, sponsors, trustees, insurers, sureties, successors and assigns, as well as all race participants, their officers, directors, employees, agents, volunteers, contributors, sponsors, trustees, insurers, sureties, successors and assigns, and each of them, of and from any and all liability, claims, demands, actions and causes of action whatsoever, of every kind and nature, whether arising out of contract, tort, statute or otherwise, in law or in equity, including all claims for negligence, recklessness and strict liability, compensatory, special, liquidated and punitive damages, penalties, costs, expenses and attorneys' fees, arising out of or related in any manner whatsoever to any loss or injury, including death, that may be sustained by the undersigned, or any property of the undersigned, relating to his/her participation as a passenger in the Iditarod Sled Dog Race.

**THE UNDERSIGNED**, being duly aware of the physical requirements, risks and hazards inherent upon participating as a passenger in said race, hereby elects to voluntarily enter said race, knowing that it may be a hazardous and dangerous activity prohibitive to some persons. The undersigned hereby voluntarily assumes all risks of loss, damage or injury, including death, that may be sustained by the undersigned, or any property of the undersigned, related to the undersigned's participation as a passenger in said race.

**THE UNDERSIGNED** acknowledges that he/she is releasing all claims that he/she might have in the future relating to participation as an Idita-Rider, even those for damages and injuries which may be caused by the sole negligence, carelessness or fault of the ITC and related persons.

**THE UNDERSIGNED** hereby gives the ITC permission to collect and use information and illustrations (which may be the undersigned's name, photograph, biographical information, and likeness) relating to his/her participation as an Idita-Rider in the Iditarod Sled Dog Race. The undersigned agrees that he/she does not expect to be compensated for any such usage, nor will he/she hold the ITC liable for any such usage. The undersigned is aware that such usage is not limited to but may include promotional efforts undertaken by the ITC and/or its licensees, agents, or assigns. The undersigned understands that the information and illustrations may be provided to print, radio, and television journalists.
